

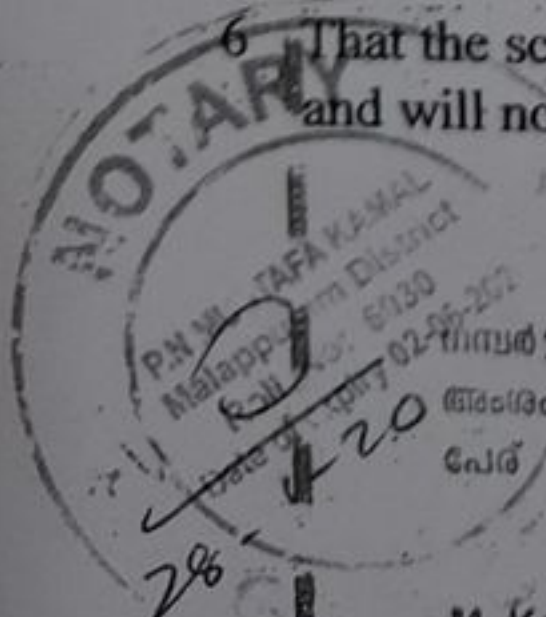

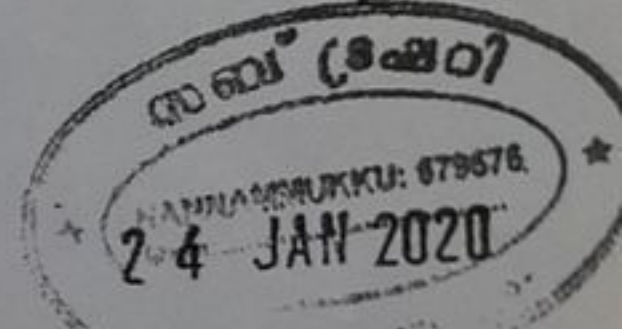

- 16 That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that the school has complied with all the conditions imposed by CBSE and the postaffiliation conditions contained in affiliation byelaws along with general rules.
